## METER RATES

Meter rates help pay for the costs associated with operating and maintaining EVWD's water treatment and delivery system. These charges are determined by meter size, not by the amount of water delivered.

## FIRE SERVICE CHARGES

Fire protection charges reflect a monthly service charge, based on connection size, for private fire services. These charges cover the costs associated with maintaining facilities and do not typically apply to most residential customers.

## COMMODITY RATES

Commodity rates cover costs that vary based upon the amount of water delivered. Residential rates reflect a three tiered rate structure based on monthly HCF. Commercial rates utilize a fixed tier structure.

## NON-RESIDENTIAL VARIABLE CHARGE†

<b>Mixed Meters**</b> <i>Qualifying accounts that utilize one meter to measure indoor and outdoor usage.</i>	\$ 1.89
<b>Low Strength**</b> <i>Includes Patton State Hospital, retail shops, schools and churches serviced by one meter, and other services.</i>	\$ 3.21
<b>Medium Strength**</b> <i>Laundromats, auto repair/service stations, and convalescent homes.</i>	\$ 3.60
<b>High Strength**</b> <i>Includes restaurants, hotels, and supermarkets.</i>	\$ 5.16
